


ur mission is to improve lives and create bright futures for people we serve by providing professional mental health, child welfare and support services in a manner that respects the dignity and individuality of each person.



# IMPROVING LIVES

#### **Community Mental Health Services**

Aldea offers outpatient therapy and psychiatric services, case management and therapy for youth at risk of delinquency and/or in the juvenile probation system, support for parents with children who have emotional challenges, and Mental Health First Aid (MHFA) training to help people understand, identify, and respond to signs of mental

Aldea Day Adolescent Program for Treatment (A.D.A.P.T.)

In partnership with Napa Valley Unified School District, A.D.A.P.T. provides a highly-structured, therapeutic school setting for special education-qualified high school students who need emotional support to succeed academically and avoid out-of-home placement.

#### **Supported Living Services**

Aldea provides case management, personal assistance with life skills and employment, support groups, and recreational activities for adults with developmental disabilities so they may continue to live

# OUR **ACCOMPLISHMENTS**

"HE SHOWED ME THE BEST OF THE HUMAN SPIRIT"

"What we do is an act of faith," explained Janine, an Aldea therapist. "We have a brief time with our clients, and then we say goodbye, hoping for the best." When Daniel, a boy diagnosed with Attention Deficit Hyperactivity Disorder (ADHD) and anxiety, left her care, Janine was optimistic.

Daniel first came to Aldea at nine years old. His greatgrandmother raised Daniel and his siblings when their parents, plagued by substance abuse, were no longer able to care for them. After Daniel's diagnosis, he met regularly with Janine for five years and learned how to manage his symptoms. With the support of Janine and his family, Daniel made significant progress and was able to graduate from therapy.

Then, at 18-years-old, Daniel began to struggle with heightened symptoms. He knew that without help, he would not be able to reach his goal of graduating from community college. When Daniel contacted Aldea on his own, four years after his last visit, he met with Janine again. And, like they had done so many years before, they talked. She listened to his fears. She praised him for his honesty, humility, and courage. They worked together to establish new coping techniques. Daniel, constantly determined to become independent, secured two part-time jobs and took steps to discontinue his social security benefits. He then navigated financial aid paperwork so he could continue his education. And, after two years, Daniel graduated from Solano Community College.

"When I asked Daniel how he was able to make such smart and difficult decisions, he simply answered 'I just do it," Janine

recalled from their recent conversations. "But it really takes an unwavering determination to succeed and a willingness to get help—plus a community of support. Daniel showed me the best of the human spirit."

#### "I KNOW I CAN ASK FOR HELP ANYTIME I NEED IT."

Karin, a woman with mild developmental disabilities, began her lifelong battle with eating disorders in her youth, which was laced with substance abuse and family violence. Following the death of her mother, Karin's weight dropped below 100 pounds. "I thought I would die," Karin later explained to her case manager. Karin's sister stepped in to nurse her back to health, and Supported Living Services helped Karin learn to thrive as an independent woman.

At 52-years-old, despite Karin's confidence and composure, she continued to be haunted by her past of calorie-counting, meal-skipping, and purging. Last year, after struggling with difficult relationships, Karin recognized that it was time to break down her façade and ask for help. "My eating disorder is out of control," she told her case manager in a rare moment, admitting to a weight loss of more than 25 pounds.

Karin's case manager immediately linked Karin to an Aldea counselor who specialized in treatment of eating disorders. Through a challenging year of hard work, Karin significantly improved her health. She expressed her gratitude to Aldea, realizing that if she ever feels overwhelmed, or if she just needs advice, "I know I can ask for help anytime I need it."

# **CREATING BRIGHT FUTURES**

**Treatment Foster Care & Adoption Services** 

Aldea provides emergency, long-term, and intensive treatment foster care—including placement, case management, and therapy for children removed from their birth families due to abuse, neglect or emotional disturbance. Aldea also recruits, certifies, trains, and supports foster and prospective adoptive parents.

Redwood Residential Treatment Center & Aldea Nonpublic School

Redwood Residential Treatment Center, a Rating Classification Level (RCL) 12 group home, provides therapy, psychiatry, support services, and 24-hour care and supervision for adolescent boys with mental health and behavioral issues. Serving the same target population, Aldea Nonpublic School is a certified alternative nonpublic school that offers educational, behavioral and emotional support through a small teacher-to-student ratio.

#### "YOU KEPT YOUR PROMISE... WE'RE GOING TO BE A FAMILY FOREVER!"

Overcome with joy, Sheena treasured the words of her newly adopted son as tears rolled down her cheeks. She could not believe that this kind, loving boy was the same aggressive, defiant toddler who entered her life just two years before.

Jason was her first foster child. She spent months preparing herself, working intensively with Aldea to become a certified foster parent. She recalled their first day together: her home neat and clean, his bedroom set up with colorful curtains and filled with new toys and clothes. She eagerly embraced him, this young child—a victim of his parents' drug abuse—who only knew neglect.

His hitting. His screaming. His kicking. It all seemed so distant now, memories of his extreme behavior replaced with images of him reading, playing with cars, and riding his bicycle—his "favorite thing in the whole wide world." As Jason embraced his new mother, Sheena realized that this boy, who had risen from such agony, was her world. Her future. Her family forever.

# "I FAILED MANY TIMES, BUT KEPT GOING UNTIL I STARTED TO SUCCEED."

After leaving a more intensive group home, Sam struggled as he transitioned to his new life at Redwood: he was suspended from school several times for fighting, got behind in academic credits, and even antagonized police during an intervention.

Then, after several months, Sam began to change. He started to appreciate positive praise and guidance from staff, realizing they truly wanted him to succeed. Excited at the idea of becoming self-sufficient, he learned how to create a resume and to interview for jobs. In only a few months, Sam earned a job at a fast food restaurant, caught up on academic credits, and started to save money. Right before Sam turned 18, he moved into an Aldea foster home and continued to meet with his therapist weekly, wanting help as he transitioned to his own apartment after his 18th birthday. With the ambition of becoming an attorney, Sam began classes at Napa Valley College.

Three years later, in his last semester, Sam was excited to be accepted as an Aldea School intern. "It was really a gift to be able to give back to those kids," explained Sam, reflecting on his experience mentoring Redwood boys. He could not believe that he had felt their same anger, hurt, and stress only four years earlier. "I failed many times, but kept going until I started to succeed. Once I found out how to succeed, I continued to keep those habits up."

A few months after graduating at the top of his class, Sam could not conceal his joy as he stared at his acceptance letter... UC Berkeley. He was on his way to realizing his dream: success, but more importantly, making a difference in the world as Aldea had done in his own.


